## Construction Monitoring and Community Liaison (CMCL) Advisor Coastal GasLink Pipeline Project

Location: Canada (CA) – British Columbia Chetwynd

### General Information:

The Construction Monitoring and Community Liaison (CMCL) Program for the Coastal GasLink Pipeline Project is seeking CMCL Advisors. The CMCL Program provides opportunities for Indigenous participation in construction activities within their traditional territories.

This role requires an understanding of Indigenous -specific values and sites of significance, interest in pipeline construction activities and adherence to safety requirements. Reporting to the CMCL Coordinator, the CMCL Advisor will be on-site observing and reporting on construction activities in their traditional territory to both the Project and their Indigenous community. CMCL Advisors will have opportunities to observe the following construction activities:

Clearing	Trenching
Grading	Lowering-In Backfill
Stringing	Buoyancy Control
Bending	Crossings (Roads, Pipelines, Water Course)
Welding	Tie-Ins
Coating	Hydrostatic Testing

### Responsibilities:

Responsibilities may include, but are not limited to:

- Support the implementation of the Heritage Resource Discovery Contingency Plan and the Traditional Land Use Sites Discovery Plan (if required)
- Attend daily tailgate meetings with Construction personnel to discuss construction activities and updates
- Identify areas of interest for observation to the CMCL Coordinator
- Observe construction activities
- Record observations
- Complete and provide daily and weekly reports to the CMCL Coordinator
- Provide regular updates to Chief and Council and community members accompanied by a Coastal GasLink representative at a frequency determined by the community
- Be cognizant of community concerns and address these early with the CMCL Coordinator
- Comply with all safety, code of conduct and fit for work requirements

## **Qualifications and Education:**

### **Qualifications**

- knowledge of Indigenous-specific values and sites of significance
- willingness to travel, work designated shifts and reside in camp accommodation
- must be fit to work in a field construction environment including completion of an alcohol and drug screen prior to working on-site
- willingness to work shift schedule: 6 days on – 1 day off (5-8 hours/per day including travel time)
- Proven team player with the ability to work effectively in cross-functional teams and cross-cultural environments
- prior pipeline or general construction experience preferred
- Strong interpersonal, problem solving and communication skills

### **Education / Experience**

- Successful completion of a relevant training program (e.g. BEAHR, First Aid, environmental training) considered an asset but not required
- WHIMS training considered an asset but not required

- This position is field-based and may require residing in a construction camp setting.
- This position may require candidates to have and maintain a valid driver's license
