  - a) Posted on or before the **8<sup>th</sup>** day of **March 2017**, at **MLIB Administration Buildings**, and made available by contacting the Electoral Officer.
11. The Nomination Meeting was held on the **17<sup>th</sup>** day of **April 2017**, at the **MLIB Band Hall** from **6:00PM to 9:00PM**.
  - a) All candidates were provided the required forms, instructions and notices pursuant to the FNEA; as well as follow-up email and text correspondence with those nominees for whom contact information was provided.

- b) The nomination period we kept open pursuant to and in accordance with the McLeod Indian Band Custom Election Code, and closed officially at 9:00PM April 26<sup>th</sup> 2017.

- a) Total number of mail in ballot packages sent to members: **241**

- c) Total number mail in ballot packages rejected: **10**
  - i. Mail in ballot packages were rejected because declarations envelopes were not signed by the candidate and/or the witness, or were not included.
