**CONFIRMED BAND PROJECTS
MLIB 2018-19 BUDGET**

Please be advised that the MLIB Board of Trustees have Confirmed eleven (11) Band Projects as eligible for funding in the MLIB 2018/19 Budget year for a sum total of [REDACTED] to be disbursed from the Provincial Revenues Trust - Project Account.

As per Section 6.2(c.) of the Provincial Revenues Trust Agreement, it is now up to MLIB Members to review these Band Projects and decide if you agree that they should be funded.

Details of the Band Projects will be posted on the Band website, at the Band office in McLeod Lake, and at the satellite Band office in Prince George B.C.

You will see one (1) page summary for each Band Project, which is the Confirmed Request submitted by MLIB Chief & Council. Please review the attached summaries of the Confirmed Requests. The Provincial Revenues Trust Agreement clearly states that the Trustees can provide to any Member all disclosures made by Council together with the Confirmed Request information.

You will also find a "Referendum Vote Request" (Schedule B), submitted with this information. This is the form you would sign and submit if you have any objections or disagree with use of the Provincial Revenues Trust funds for these Band Projects.

Pursuant to Sec. 6.2(g) of the Provincial Revenues Trust Agreement, if within twenty one (21) days following this posting of a Confirmed Request, Band Members, representing no less than 25% of the Band membership, who have attained 18 years of age, may deliver a "Referendum Vote Request" to the Trustees, in single form or counterparts, the Trustees will then present this to Council.

The following can then occur:

- The Council may withdraw the Confirmed Request
- The Council may change the Confirmed Request ensuring all conditions and provisions relating to processing this request still apply, per Section 6.2(d).
- Council may direct the Trustees to conduct a Referendum, according to the rules of this Trust Agreement, to consider approval of one or more of the Confirmed Request.

PLEASE NOTE: It is our understanding that as of March 31, 2019 the unconfirmed estimate of the McLeod Lake Indian Band eligible voters is 400, and 25% of that, for a Referendum Vote Request would be 100 Band Members.

PLEASE NOTE: You must include a copy of the Confirmed Request project sheet, which includes details of this project, with the signed Referendum Vote Request.

Copies of the documents can be printed off the website or on location in the Band office in McLeod Lake.

Please be advised that Band members have until **March 10, 2019**, being twenty one (21) days from the posting date; to review this Confirmed Request and submit a Referendum Vote Request form, if they so choose.
