Oversight Committee Summarized

In accordance with the MLIB Land Code, 2022, an Oversight Committee must be established.

- a) The role of the Oversight Committee is critically important in ensuring the effective implementation and adherence to provisions and requirements set forth in the MLIB Land Code, Land Laws, Plans, or Policies and the Land Use Plan.
- b) The purpose of the Oversight Committee is to review referrals that are brought forward by MLIB Eligible Voters.

The Oversight Committee will play a supportive role in ensuring transparency, accountability, and effectiveness within McLeod Lake Indian Band operations as they pertain to our Treaty Lands. The committee will aim to work with the subject of the referral to advise them on how to better adhere to relevant regulations and guidelines.

- The Oversight Committee members will be appointed by the Land Management Committee.
- Term of Office is up to 3 years.
- The Oversight Committee will consist of 6 eligible member voters and
- 1 non-member who must have legal or adjudicative training.
- The Land Management Committee will establish terms of reference and may create policies and procedures for the Oversight Committee.
- The Oversight Committee will be notified of any violations of the Land Code except where the Land Management Committee or Land Management Office is the subject of the referral, in which case it will be received by the Band Administrator.

This collaborative relationship between the Oversight and Land Management Committees works towards better protecting our treaty lands while committees work towards democratic governance measures that are put in place to protect our Treaty lands while promoting sustainable development for future generations.
